

## CULTURAL EXPERTISE, LAW, AND RIGHTS: THEORY, DEBATES AND CASES

*This course focuses on cultural expertise and the theoretical and applied components of the major debates and controversies related with the engagement of social scientists with law*

## CULTURAL EXPERTISE AND ASYLUM AND REFUGEE LAWS

*This course focuses on the work of different legal actors who engage with the legal process of cultural expertise to assist asylum applicants to secure international protection, explains key legal concepts, and modalities of experts' appointments for the assessment of evidence in asylum and refugee laws*

## CULTURAL EXPERTISE AND CONFLICT RESOLUTION: MEDIATING DIVERSITY

*This course focuses on cultural expertise in conflict resolution, with a focus on mediation, by giving a theoretical as well as practical insight into mediation as a tool for conflict resolution*

## CULTURAL EXPERTISE AND EXTREME SPEECH

*This course focuses on the role of cultural experts in assisting in extreme speech cases, with a focus on the challenges and mitigating strategies associated with expert witnessing*

## CULTURAL EXPERTISE AND HISTORY

*This course focuses on the role of historians as cultural experts and on the use of historical evidence in litigation in selected geographic areas*

## CULTURAL EXPERTISE AND INDIGENOUS LANGUAGE

*This course focuses on the loss of Indigenous languages as a cause of poor mental and physical health, and on cultural expertise as a tool to better understand the social, psychological, and physical effects of fostering Indigenous languages*

## CULTURAL EXPERTISE AND INTERNATIONAL HUMAN RIGHTS LAW

*This course focuses on the procedural requirements for providing cultural expertise and appointing cultural experts and on the different*

## CULTURAL EXPERTISE, THE TREATMENT OF PERSONAL DATA AND THE USE OF INCLUSIVE LANGUAGE

*This course focuses on the treatment of personal data and the use of inclusive language in court and legal documents*

## CULTURAL EXPERTISE AND COMMERCIAL ARBITRATION

*This course focuses on cultural expertise in commercial arbitration for what pertains to the identity of the arbitrator, the applicable rules or laws to the dispute, and the procedural rules*

## CULTURAL EXPERTISE AND ETHICS

*This course focuses on the professional ethics of cultural expertise and cultural experts*

## CULTURAL EXPERTISE AND FEMALE GENITAL MUTILATION/FEMALE CUTTING (FGM/FC)

*This course focuses on cultural expertise in the legal proceedings of cases that involve female genital mutilation/cutting (FGM/FC)*

## CULTURAL EXPERTISE AND INDIGENOUS ECOLOGIES

*This course focuses on the role of cultural expertise in ecological controversies related to the legal status of ecological traditions and practices of Indigenous communities, with a focus on the cultural and historical biases embedded in Eurocentric legal systems and the complexities and tensions that characterize the involvement of cultural experts in these conflicts*

## CULTURAL EXPERTISE AND INTERNATIONAL CRIMINAL LAW

*This course focuses on the role of cultural expertise in international tribunals, with a focus on the International Criminal Tribunal for Rwanda, the International Criminal Court and the Special Court for Sierra Leone*

## CULTURAL EXPERTISE AND INVESTIGATIVE JOURNALISM

*This course focuses on the role of investigative journalists as cultural experts in criminal trials that involved allegations of*

*uses of cultural expertise, with a focus on the European Court of Human Rights and the Inter-American Court of Human Rights*

### **CULTURAL EXPERTISE AND LGBTQIA+**

*This course focuses on the role of cultural expertise in LGBTQIA+ issues in the courts and judiciary, with a focus in the UK's legal system*

### **CULTURAL EXPERTISE AND MULTICULTURALISM**

*This course focuses on how anthropologists and other cultural experts have become involved with legal proceedings and what has happened in their encounters with the law and with lawyers from the perspective of multiculturalism*

### **CULTURAL EXPERTISE AND RACE**

*This course focuses on the application of the concept of race in asylum courts in the United States, in community organizations confronted with conflicts in refugee and immigrant populations, and in racial profiling against African Americans*

### **CULTURAL EXPERTISE AS DECOLONISATION**

*This course focuses on the role of cultural expertise as an effective instrument for the dismantling of inequitable colonial structures and decolonisation*

### **CULTURAL EXPERTISE IN EUROPE**

*This course focuses on the use of cultural expertise, the types of cultural expertise and the ways in which cultural experts are identified and appointed in Europe*

### **CULTURAL EXPERTISE IN SOUTH AFRICA**

*This course focuses on the role of cultural expertise in South Africa, with a specific emphasis on plural sources of law, the ascertainment of customs, and the appointment of cultural experts*

### **CULTURAL EXPERTISE IN THE ARAB MIDDLE EAST**

*This course focuses on the conceptualisation of cultural expertise within the legal systems in the Middle East*

*witchcraft and sorcery, with a focus on Central African Republic, Cameroon, and Tanzania*

### **CULTURAL EXPERTISE AND THE MEDIA**

*This course focuses on media literacy as a particular kind of cultural expertise, requiring an interdisciplinary approach and careful translation of knowledge in the legal environment*

### **CULTURAL EXPERTISE AND PROCEDURAL JUSTICE**

*This course focuses on how cultural expertise promotes litigants' voices and understanding of what goes on in court, and ensures their respectful treatment, which is conducive to trust in the courts and legal system*

### **CULTURAL EXPERTISE AND TERRORISM**

*This course focuses on cultural expertise and terrorism and the ways in which anthropologists can be engaged as independent experts*

### **CULTURAL EXPERTISE IN SOUTH AMERICA**

*This course focuses on the use of cultural expertise in the form of cultural defence in criminal proceedings in South America*

### **CULTURAL EXPERTISE IN ISLAMIC COURTS IN INDONESIA**

*This course focuses on the use of cultural expertise in the integration of local practices in the process of gender sensitization of the Islamic courts in Indonesia, with a focus on cases concerning polygamy, matrimonial reconciliation, and divorce settlement*

### **CULTURAL EXPERTISE IN SOUTH ASIA**

*This course focuses on the use of various forms of cultural expertise in South Asian legal systems, with a special focus on India and Pakistan*
